LOCATION

This property is located at the rear of the estate off Foster Road on the Sevington Business Park which itself is located on the western side of the A2070 (Bad Munstereifel/Orbital Road), only a couple of hundred yards south of Junction 10 of the M20 motorway. These units were built in the 1990s and form part of a well-established complex with many units being used as trade counters.

Ashford, one of Kent's designated growth centres, currently has a population of approximately 75,000 inhabitants and is set to grow substantially in the next 20 years. The town is centrally located within the county, benefitting from a fine communications network via the A20/M20 and five mainline railways. Ashford International Passenger station can give direct access to northern continental Europe via Eurostar and London is some 38 minutes distant via HS-1.

DESCRIPTION

Unit 6 is a mid-terraced unit of steel portal frame construction and provides approximately 8,700 sq.ft of accommodation. There is an eaves height of approximately 18ft rising to an apex of some 24ft 6in. The unit benefits from an up-and-over folding door some 9ft 10in wide by 13ft high, a concrete floor, skylights within the roof, glazing to two elevations and generous parking to front and rear. There are also WCs and a small kitchen area.

ACCOMMODATION

Workshop/Warehouse: 8,684 sq.ft.

SERVICES

All main services are connected to the premises.

There is a 3-phase (200 amp) electrical supply.

BUSINESS RATES

The premises require re-assessment following the division of Units 6 and 7.

The uniform business rate multiplier for the year 2024/25 is 49.9p.

TERMS

The premises are available by way of a new fully repairing and insuring lease, the terms of which are negotiable. A rent in the region of £95,550 per annum is being sought. An annual service charge is payable towards the upkeep of the common parts of the estate. The Service Charge payable for 2024 is £4,106.02.
